Please read the following document carefully.

Every learner from Grade R to Grade 9 must be registered with the Department of Education as a homeschool learner, for ages 5 to 15. Forms will be provided upon request or are available on our website. This registration is the responsibility of the parent, according to law.

From January 2023, we started using the CAPS curriculum – the same curriculum currently offered in schools. No other curriculum will be followed for learners.

Learners can start at Grade R and continue with the same program up to Matric (Grade 12). In Matric, learners complete the year and thereafter receive an internal certificate with their yearly average, which can be added to their CV. It is important to understand that this is **not** a National Senior Certificate (NSC). There are several options to obtain an NSC or similar certificate after the matric year, such as Adult Matric (Second Chance Program).

Your child must have a cellphone, tablet, laptop, or computer to work from. The work is done through an application (App) which can be used offline, but it must be synchronized as often as possible so that we have access to your child's work.

Another benefit of the CAPS curriculum is that it is exactly the same work as done in schools, which means children who want to return to school can adapt easily.

You will be provided with daily work instructions showing exactly what your child must do. For exams, parents must understand that **no demarcations and summaries of work** will be provided. Learners write exams in Term 2 and Term 4 and complete assignments in Term 1 and Term 3.

After each term, a progress report/report card will be issued.

The expectations from the Department of Education are the same as for schools. In short:

- Attendance must be recorded.
 - There must be a weekly timetable and an annual plan, as well as assessments/exams.
 - The learner's work must be collected in a portfolio, which must be kept for at least three years.
 - There must also be a physical space with sufficient light, air, and facilities where your child is taught.
 - At the end of Grade 3 and Grade 6, your child must again be registered with the Department of Education for the next phase.

Fees:

As soon as you enroll your child or children, the following applies:

- All learners must have a laptop/desktop, phone, computer, or tablet on which the application (App) is installed.
- **Note:** The registration fee is payable upfront together with the fee for the first month of enrollment. No learner will be allowed to begin with the work if the registration fee and first month's fee have not been paid. The due date is the **6th of every month**, payable in advance for the month to come.

Fees are as follows:

- Registration for Grades R–12: **R500 per year**
- Fee for Grades R–12: **R7 200 per year once-off per learner** OR payable in installments over 12 months at **R600 per month**

NOTE!

Fees must be fully paid on or before the 6th of every month. We also have obligations, please take this into consideration.

Fees are payable for 12 months, from January to December.

If fees are not paid, all support from GAP aanlyn will be suspended. In such a case, GAP aanlyn will completely withdraw from the learner. The application (App) runs on a managed system. If your child's payment is not made by the 6th, your child's profile will automatically be blocked and cannot be reactivated until fees are up to date. The system must first register your payment before your child's profile can be reopened.

We are not a charity and expect parents to honor their responsibility. Please make your child's education a priority, because if you do not pay, it is your child who suffers.

If you cannot or do not want to comply with the above, we suggest that you rather keep your child in a regular school, or not make use of our services.

We recommend that you set up a debit order with your bank. We do not want to ask for our fees every month. As a parent, you must make your child's education a priority and adhere to the agreement. Our fees are already the lowest in South Africa and cannot be reduced further.

When fees are not paid and GAP aanlyn suspends all support, please do not be upset with us. We hold nothing against you personally, and as soon as fees are settled, we will gladly allow you to continue using our services. We have an agreement, and we honor our part — we expect every parent to do the same.

Please note: just as with a DSTV or internet subscription, if you do not pay, the provider suspends your services — and usually, there is also a reconnection fee before you can use it again. GAP aanlyn does not charge a reconnection fee when your child's profile is blocked. We only ask that you keep fees up to date, and if your child's profile is blocked, kindly settle the outstanding amount.

What does my child need?

- Every learner requires a laptop, computer, cellphone, or tablet.
- An internet connection to synchronize your child's work with the application (App) as often as possible, preferably once a week and or after every assignment and end-of-term exam.
- 1 x blank exercise book per subject for summaries to prepare for assignments and exams.

- At the end of each term, there will be assignments/exams. Every mark counts towards the year-end result.
- Progress reports will be issued at the end of each term.
- **Note:** NO tests or exams may be written open-book. Children must complete exams under the supervision of a reliable family member, parent, or another institution. We place great value on our credibility.

Fee Agreement:

I, as the parent, commit to paying for the full package from the time of enrollment. I further commit to paying the fees allocated to each learner monthly for the full 12 months (from January to December) or from the time of enrollment until year-end.

If I fail to pay for a given month, GAP will have no further responsibility towards my child regarding the use of the application (App) or the issuing of reports.

I understand and agree that if I have paid monthly or annually in advance and then decide to return my child to a school, I will only receive a pro-rata refund of fees after deducting the current month's fee. Even if my child only used GAP's services for 1 day in the month, a full month's fee will be withheld.
